NOTICE IS FURTHER GIVEN THAT at such meeting the Board of the Authority intends to make a final determination to issue and refund the Authority’s outstanding indebtedness consisting of its: (a) Limited Tax Supported (District No. 1) Revenue Refunding Bonds, Series 2025A; and (b) Subordinate Limited Tax Supported (District No. 1) Revenue Refunding Bonds, Series 2025B, in the total combined aggregate amount not to exceed \$50,500,000, or as otherwise permitted by any resolution adopted by the Board for the purpose of refunding a portion of its existing bonded indebtedness, and in connection therewith the Board will consider a resolution: authorizing the issuance of such indebtedness; authorizing two separate Indentures of Trust, two separate Pledge Agreements, a Bond Purchase Agreement, a Continuing Disclosure Agreement, the form of Official Statement related to the issuance of such bonds, and other related documents; approving, ratifying and confirming the execution of certain documents; making determinations and findings as to other matters related to such financing transaction; authorizing incidental action; and repealing prior inconsistent actions.

NOTICE IS FURTHER GIVEN THAT pursuant to the Supplemental Public Securities Act, no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of such bonds may be commenced more than thirty days after the authorization of such bonds pursuant to the aforementioned resolution.

The Board will also take up such other business as may come before the Board. The meeting is open to the public.

Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Board may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device. There will be at least one person present at the physical location posted on this notice.

This notice is given by order of the Board of the Authority, and shall be posted on the Authority’s website, not less than 24 hours prior to the meeting.
